As a Motor Carrier Safety Specialist with the Federal Motor Carrier Safety Administration I independently plan, schedule, and conduct compliance reviews on motor carriers throughout the State of Alabama to assure compliance with regulations, policies, and /or guidelines, including those concerned with the transportation and handling of hazardous materials. At the conclusion of the investigation, using the evidence I collect, I determine whether prosecution is warranted. I provide advice on investigations, compliance reviews, hazardous materials and related activities throughout the State. I provide updates on Agency Memorandums and Federal Motor Carrier Safety Regulations to Federal Safety Investigators and State Troopers that conduct compliance investigations.

I conduct roadside inspections on interstate motor carriers that operate in commerce throughout the State of Alabama to assure compliance with regulations, policies, and /or guidelines, including those concerned with the transportation and handling of hazardous materials.

I served as an assistant instructor during the Part A course of the Federal Motor Carrier Safety Administration Safety Investigators class during the 2010 session. During the Part A course my blocks of instructions were on commercial vehicle recognition, CDL, and Hours of Service. I have provided training to Federal and State investigators in Alabama on Safety Measurement System methodology, and ban on cell phones.

I organized and implemented the 2011 Motor coach Bus Summit that was conducted by the Alabama Division of the Federal Motor Carrier Safety Administration. During the Bus Summit I presented an update on Driver Qualifications. I was the Alabama Division's point of contact during the 2012 National Road Check and National Passenger Carrier Strike Force. During the road check and strike force I monitored the activity of the Alabama Department of Public Safety Inspectors and prepared a monitoring report for the Alabama Division Administrator. I have represented the Alabama Division of the Federal Motor Carrier Safety Administration and provided regulatory updates to the Alabama Motor Coach Association and Alabama Governor's Safety and Health Conference.

I assisted the Federal Motor Carrier Safety Administration's Trial Attorney documenting evidence for a case that was going before an Administrative Law Judge. I have also worked with the Trial Attorney documenting evidence for the Field Administrators Reply to Preliminary Order on Petition for Review of Safety Rating.

I acted as the Alabama State Program Manager for the Alabama Division from February 2012 until July 2013 and March 2014 through May 2014. While acting as State Program Manager, I processed reimbursement request, reviewed quarterly reports, grantee refunds, and grant extensions. I processed grant amendments and provided assistance to the Alabama Division Administrator and Southern Service Center State Program Manager. I monitored and prepared a monitoring report for the North American Standard Part A and B course instructed by the Alabama Department of Public Safety Motor Carrier Safety Unit. I participated and monitored the annual Commercial Vehicle Enforcement retraining conducted by the Motor Carrier Safety Unit. I conducted covert and overt monitoring of the Alabama CDL skills testing and prepared a monitoring report for the Alabama Division Administrator. I assisted the Alabama Division Administrator with the review of the Alabama Department of Public Safety's 2013 CVSP. I assisted the Alabama Division Administrator with the annual Risk Assessment of the Alabama Grantee's. I reviewed highly technical projects and programs such as the Motor Carrier Safety Assistance Program (MCSAP); Commercial Driver's License (CDL) Program; Performance and Registration Information System Management (PRISM); the New Entrant Program; Commercial Vehicle Information Systems and Networks (CVISN) and provided advisory and technical guidance to the Division Administrator.

I currently assist the Alabama Division Administrator with outreach activities conducted by the Alabama Division. During the calendar year 2013, the Alabama Division Administrator created the Motor Coach Passenger Action Committee (MPAC). I serve as the Point of Contact for the Division Administrator and coordinate the MPAC meetings and other safety talks. I serve as the motor coach outreach coordinator for the Alabama Division Administrator. I monitor and track the motor coach activity conducted by the Alabama Department of Public Safety and report the activity to the Alabama Division Administrator.
