

Jeffrey M. Wilder, DC, DABCO, FICC

Curriculum Vitae

Dr. Wilder graduated from Madison East High School in 1974, a National Honor Society member and a National Merit Scholarship Finalist. He completed undergraduate studies at the University of Wisconsin-Madison and graduated with *cum laude* honors from Palmer College of Chiropractic, Davenport, Iowa in 1981 as a Doctor of Chiropractic. He served at Palmer College as a radiology intern, and as his class president. In addition to the required curriculum, a 100-hour radiology course and a 90-hour specialized technique course were completed. Dr. Wilder is a 1981 diplomate of the National Board of Chiropractic Examiners.

Engaged in private family-oriented practice as a chiropractor in Madison, Wisconsin since 1981, Dr. Wilder has completed a post-doctorate program in chiropractic orthopedics from National College and is a Diplomate of the American Board of Chiropractic Orthopedists and a Fellow of the International Academy of Neuromuscular Medicine. This program is successfully completed by less than 1% of the nation's chiropractors. He has also been certified by the American Chiropractic Association Sports Council as certified in chiropractic sports medicine, a 120-hour certificate program dealing with sports training, and the treatment and prevention of sports injuries.

Dr. Wilder has completed additional training in physiological therapeutics [48 hours], surface EMG [12 hours] and clinical nutrition [48 hours] meeting Wisconsin requirements for these additional practice areas. He was also certified in 2004 in the Graston Technique, an innovative method for treating soft-tissue injuries. He is certified in the use of low-level laser and light therapies.

He is a certified instructor for the American Red Cross *Protect Your Back* program. He is also certified by the National College of Chiropractic, Lombard, Illinois in Impairment and Disability Rating.

In August of 1993, he was elected to an honorary Fellowship in the International College of Chiropractic in recognition of his 'valiant service' to the chiropractic profession.

Dr. Wilder currently serves as the representative for the chiropractic profession to the Wisconsin Medicare Carrier Advisory Commission as well as the American Chiropractic Carrier Advisory Committee for Medicare-related issues.

He has participated in Governor Thompson's Health Care Summits. He was a member of Senator Russ Feingold's Regional Health Care Advisory Committee. He has been a frequent spokesperson for chiropractic in the press, television and radio, including regular appearances on statewide Wisconsin Public Radio.

Dr. Wilder served for many years on the Board of Directors for the Wisconsin Chiropractic Foundation, a non-profit organization which funded and developed chiropractic research and education. He is a past member of the Advisory Council for the Wisconsin Back Society, an interdisciplinary academic group. He has also served as an officer on the Board of Directors for the Congress of Chiropractic State Associations, which commissioned the chiropractic profession's first nationwide clinical practice guideline, known as: *Guidelines for Chiropractic Quality Assurance and Practice Parameters: Proceedings of the Mercy Center Consensus Conference 1993*, Aspen Publishers, Gaithersburg, MD.

Dr. Wilder is a Past President of the 1800-member Wisconsin Chiropractic Association, after having served as President from 1991 to 1997. His six-year term as President of the Wisconsin Chiropractic Association is one of the longest terms in the 100+ year history of the organization. He served as chairman and lead author of the Documentation Committee, as well as the Protocol Committee for the Wisconsin Chiropractic Association, which were commissioned to develop minimum standards for chiropractic practice in Wisconsin. Under Dr. Wilder's leadership, the Wisconsin Chiropractic Association adopted clinical treatment guidelines in June 2000. He is a member of the Wisconsin Chiropractic Association's Chronic Care Committee.

Dr. Wilder has served the Wisconsin Chiropractic Association as Chair of its Worker's Compensation, Government Affairs, Protocol, Documentation and Clinical Advisory committees. Dr. Wilder has served for sixteen years on the Wisconsin Chiropractic Association Board of Directors.

Dr. Wilder served as a professional member of the Wisconsin Chiropractic Examining Board in 2001-2002.

Dr. Wilder is the current representative of the chiropractic profession in the State of Wisconsin to Medicare's Carrier Advisory Council. He is also the representative to the American Chiropractic Association's Medicare Carrier Advisory Committee.

Dr. Wilder has served as the Chiropractic Program Director for U-CARE and HMO of WISCONSIN health maintenance organizations.

Dr. Wilder has been used as an expert witness by both plaintiffs and defendants in motor vehicle accident cases and professional liability cases throughout a majority of the United States, as well as Puerto Rico.

Dr. Wilder has lectured extensively around the country on topics including Worker's Compensation, disability rating, clinical documentation, diagnosis, and the proper use of diagnostic, procedural and evaluation/ management coding. He was a featured presenter at the 1995 Wisconsin Back Society annual symposium on traumatic cervical spine conditions. He has served as a participant of Palmer College of Chiropractic's Practice Based Research Programs.

Dr. Wilder is a contributing author of an Appleton/Lange textbook on clinical outcomes published January 2000. He has written a textbook on Wisconsin Worker's Compensation and a conversion document for ICD-10 diagnosis codes.

Continually since July 2000, Dr. Wilder has served as a Chiropractic Expert to the State of Wisconsin [Department of Workforce Development] to adjudicate binding arbitration in the form of Necessity of Treatment Dispute Resolution for disputed Workers Compensation cases.

Dr. Wilder currently serves as a Consulting Expert to the Wisconsin Chiropractic Association, answering member questions about compliance, standard of care and clinical concerns.

Dr. Wilder is the founder and past President of a practice group known as Madison Chiropractic, with five locations and 8 doctors throughout the metropolitan area of Madison, Wisconsin. Madison Chiropractic has won the prestigious "Star of Madison" award in 2010, 2012, 2013, 2014, 2015, 2016, 2017, 2018, 2019, 2020, 2021 and 2022 for the Best Chiropractic Clinic in Madison, Wisconsin.

In September 2001, Dr. Wilder was named “Chiropractor of the Year” by the Wisconsin Chiropractic Association.

Dr. Wilder was named to the editorial board of the Journal of the American College of Chiropractic Orthopedists in January 2004.

In June 2007, Dr. Wilder was a featured presenter to the National Society of Professional Insurance Investigators on fighting fraud in the chiropractic profession. He has since served as a consulting expert on several large-scale investigations throughout the U.S., investigating and fighting health care fraud.

In October 2007, and continuing to date, he has served as the lone chiropractic representative in Wisconsin to the Workers Compensation Research Institute.

In 2012, Dr Wilder was asked to be a test question author for the American Board of Chiropractic Orthopedists.

Dr. Wilder has produced detailed medical illustrations, which have been used in various trials and hearings, to better explain anatomic relationships to judges and juries.
