Professional History

Mr. Beringer is Principal of **Beringer & Associates (B&A)** and **Liability Program Management (LPM).** These Firms provides business and municipalities liability program management, including analysis of current risk exposures involving Labor Code, Safety, and Regulatory exposures, litigation management, and Workers' Compensation analysis/consultant services.

As **B&A**, since January of 2000, the firm has provided risk analysis and management services to the insurance, construction and transportation industry. He has also been engaged to provide analysis of construction defect exposures, including review of risk exposure coverage; Labor Code exposures, including assisting with the administration of prevailing wage in California; to assist with operational concerns, logistics, risk management, Workers' Compensation underwriting, and executive management.

Previous to the formation of B&A, Mr. Beringer worked in the insurance industry for 30 plus years as a Litigation Manager for various insurance carriers, including Specialty Risk Services (Hartford), Industrial Indemnity, Great American and Western International Insurance Company. Since B&A's formation, he has assisted major insurance carriers and served as a consultant to various reinsurance and captive insurance carriers.

B&A also form/operate alternative risk transfer mechanisms for domestic and nondomestic captive programs, including purchasing and risk retention groups; assist with supervision of Third-Party Administrators, and municipal construction programs. Mr. Beringer has also provided talent for the successful handling of Government Code matters, including dangerous conditions, FEHA/DFEH, excessive force, and Civil Rights issues on behalf of those organizations.
