Duties included pre-fight examinations; sat ringside to examine boxers and stop a fight if necessary; provide emergency medical care (including emergency first aid for injuries including oxygen and defibrillation), and perform post-fight examinations to determine the health status of a boxer.

I have provided **in-school Special Olympic certification examinations for the Broward County School System**. I have also provided examinations for adult Special Olympic athletes.

I've owned racehorses and have been asked by various trainers to utilize Chiropractic techniques on their racehorses. I also developed a natural nonsteroidal anti-inflammatory product for racehorses that was entirely safe, effective, and did not violate any of the state medication laws when taken prior to racing. I am also a U.S. pharmaceutical patent holder (Patent number: 5073366, 12/17/1991).

The **Department of Veterans Affairs has me as eligible for a hospital-based Chiropractor position** based on departmental interviews and history at the Miami Veterans Hospital.

HEALTH CARE ACTIVIST

My efforts resulted in a meeting between the American Chiropractic Association (ACA) and the **Social Security Administration** (SSA)to discuss expanding the role of Chiropractic in regards to **disability examinations** (2001). I had top SSA officials ready to testify on our behalf. Unfortunately, the ACA and the FCA sabotaged this endeavor.

I worked at getting Chiropractic declared as a mandatory department in all hospitals accredited by the **Joint Commission on Accreditation of Healthcare Organizations (JCAHO)**. I had the head legal counsel of the Joint Commission convinced that this is viable and will benefit patients and eliminate the AMA's lingering anti-trust action that is keeping Chiropractor out of hospitals. I was unsuccessful on getting the American Chiropractic Association (ACA) to follow through. I had a written invitation from the Joint Commission for the ACA to meet with them to discuss my proposals.

I attempted to get the Florida Chiropractic Association to back a legislative rule change in regards to the Florida Boxing Commission that would expand **ringside physician** boxing opportunities for Chiropractic Physicians. We had the backing of the medical director of USA Boxing. The medical director of USA Boxing has approached me at a Silver Gloves Tournament to discuss his interest in expanding the role that Chiropractors play ringside, giving us parity with M.D.'s and D.O.'s at the matches. USA Boxing is the organization in the United States that sanctions amateur boxing in the United States. Although I performed all the same duties as the allopathic doctors (M.D. or D.O.), one of the M.D.'s or D.O.'s must sign off on me. Although I am authorized in Florida by my State Chiropractic license to provide all services provided at a boxing match, the Florida Boxing Commission restricts ringside physicians to holders of M.D. or D.O. degrees. I did not receive the backing or the interest of the Florida Chiropractic Association.

STANDARDS OF CARE

Specific imaging studies, as well as laboratory testing, and other established diagnostic testing procedures are ordered by me when medically indicated to help establish an accurate differential diagnosis. Each patient receives an accurate medical diagnosis based on a thorough case history; physical, orthopedic, and neurological examination; and diagnostic testing when indicated, to arrive at an accurate ICD-10 differential medical diagnosis as well as an accurate chiropractic biomechanical assessment.

The following classes taught by me are offered to State Chiropractic Associations: a class on the examination of Special Olympic Athletes; Common Boxing Injuries and the Chiropractor as a Ringside Physician; the Proper Performance of Independent Medical Examinations, and An Integrated Technique and Biomechanics Class on Chiropractic Manipulative Care.
