## **PROFILE OF PRESENT WORK**

<u>Fall 2007 to the present</u> - Expert witness testimony: Janice A. Ramsay consults with other lawyers and testifies as expert witness in commercial and personal lines property insurance bad faith litigation with regard to the customs and practices of the insurance industry in handling claims of all types and especially those with coverage and policy interpretation issues. She also acts as an appraiser/arbitrator in the appraisal process under property insurance policies.

## PROFILE OF PROPERTY INSURANCE LEGAL WORK

**From 1971 to the fall of 2007**, Ms. Ramsay worked as a lawyer in the field of property insurance law. She has given claims handling and coverage advice to insurers, handled lawsuits and appeals in property insurance breach of contract and bad faith cases for insurers and insureds, handled subrogation cases for insurers, drafted insurance policy language for carriers, served as an "advice of counsel" witness and expert witness for other lawyers, and handled arbitrations and appraisals on property insurance related claims. She has been a speaker and instructor at many seminars for lawyers, insurance industry personnel and other professional groups.

<u>Areas of advice on Property Insurance Coverage and Claims Handling Procedures:</u> Ms. Ramsay has worked with all kinds of losses under personal lines and commercial property insurance claims including fires, earth movement, earthquakes, water damage, mold, defective construction, latent defects, riots, thefts and acts of civil authority. The claims have involved issues of proper claims investigation by insurers, application of case law and regulations to claims handling and coverage decisions, interpretation of policy provisions, suspected arson, organized insurance fraud, business interruption coverage calculations and application of policy terms, underwriting issues, rights to rescission or reformation, broker and agent acts in procuring insurance, insurable interest issues, claim evaluation issues, appraisals rights and procedures, the right to examinations under oath of insureds, application of the suit limitation provision and mortgagee rights to a claim.

**Litigation:** Ms. Ramsay has handled lawsuits and appeals on property insurance coverage issues, insured's rights, bad faith, and subrogation of insurers. She has the following reported Appellate Cases: *Prudential-LMI v. Superior Court* (1990) 51 Cal.3d 674, 274 Cal.Rptr. 387, (one year limitation on suit and tolling), Ms. Ramsay handled the claim and Superior Court litigation and she and her firm were co-counsel on the appeal; likewise, Ms Ramsay handled the claim and the lawsuit and supervised the appeal in *State Farm Fire & Casualty Co. v. Tan* (C.D. Cal. 1988) 691 F. Supp. 1271 (the right to take the Examinations Under Oath of insureds separately). Ms. Ramsay tried the suit and supervised the appeal of

*Carty v. American States* (1992) 7 Cal.App.4th 399, 9 Cal.Rptr. 2d 1 (applicability of the "latent defect" exclusion). Ms Ramsay handled the lawsuit and appeal in *Doheny West HOA v. American Guarantee & Liability Ins. Co.* (1997) 60 Cal.App.4 400, 70 Cal.Rptr. 2d 260 (interpretation of the collapse provision). Ms. Ramsay was a part of the team of lawyers that worked on the appeal to the *California Supreme Court of Vu v. Prudential* (2001) 26 Cal.App.4th 142 (application of estoppel to suit limitation provision).

Ms. Ramsay gave the advice in the underlying claims which advice was affirmed as correct by the courts in *Murray v. State Farm Fire and Casualty Co.* (1990) 219 Cal.App.3d 58, 268 Cal.Rptr. 33; *Waldsmith v. State Farm Fire & Casualty Co.* (1991) 232 Cal.App.3d 693, 283 Cal.Rptr. 607; and *Rosen v. State Farm General Ins. Co.* (Cal. Sup. Ct. June 12, 2003). Ms. Ramsay handled the appraisal that was the subject of *Michael v. Aetna Life and Casualty Co.*, (2001) 88 Cal. App. 4th 2d 515, 24 Cal. Rptr. 557.

## SUMMARY OF PROFESSIONAL POSITIONS AND LEADERSHIP

2007 to present: Self employed expert witness and appraisal panelist.

<u>**1999 to 2007 -**</u> From the fall of 1999 to the fall of 2007, Ms. Ramsay was a senior partner and on the management committee at Berger Kahn LLC in Irvine, California. She engaged in full time law practice specializing in property insurance law.

<u>1984 to 2007</u> - In 1984, Ms. Ramsay founded and for the next 15 years managed the law firm of Ramsay and Johnson ALC. It was also know as Ramsay, Johnson and Klunder. ALC during some of that time. This firm specialized in insurance law of all types and for much of it existence had between 15 to 21 lawyers. It was the first such law firm founded by a woman in Orange County, California. That firm merged with the Berger Kahn law firm in September of 1999.

<u>1971 to 1984</u> - Ms. Ramsay joined Cummins, White and Breidenbach (now known as Cummins & White) in Los Angeles as the firm's first women lawyer in the fall of 1971. By 1975, she was the first woman partner in the firm. She transferred with it to a newly created branch office in Newport Beach, California, in the fall of 1977. When that firm underwent a split in 1978, she remained as a partner with a successor firm, Breidenbach, Swainston, Yokiatis and Crispo, until she left to found her own firm in the fall of 1984.

1<u>969 to 1971</u> - Ms. Ramsay began her career as a lawyer at South Central Multipurpose Center in South Los Angeles doing a variety of legal projects focused on assisting community members and the Center's various projects.
